S U M M A R Y O V E R V I E W :

In September 2025, the United States launched the [America First Global Health Strategy](#). The first Afrikan country to publicly embrace this global initiative was Kenya with many Afrikan nations following. Coming from a country where its citizens struggle to get adequate healthcare and Black people have been the documented guinea pigs for multiple medical genocide experiments (see Medical Apartheid by Harriet Washington), the America First Global Health Strategy looks more like a planned "Genocide for Afrika" than health or medical assistance.

O B J E C T I V E :

The purpose of this paper is to definitively convince the reader that the America First Global Health Strategy is an extension of an ongoing genocide/extermination effort against Afrikan people worldwide. We will attempt to identify who is working at the highest levels to exterminate Black people through medical designs disguised as "health assistance" and paint a picture of how they pursue this objective. Our ultimate desire is for Black leaders throughout the world, particularly in Afrikan nations, to identify and reject anything related to Western medical initiatives as active forms of Black genocide. The first signs of success would be for Afrikan nations to collectively publicly abandon and/or reject the [America First Global Health Strategy](#).

Historical Perspective:

Point 1: Pontiac's War and the Birth of America

An appropriate starting reference point for this discussion is with the medical initiative that led to the establishment of America in 1776. Ten years earlier, in 1766, the English were on the verge of being expelled from North America by a Native American alliance under the leadership of a heroic leader named Pontiac. Pontiac was an Odawa Chief who unified a substantial coalition of Native American nations/tribes to fight against the English colonization of North America and genocide of its original inhabitants.

Pontiac's Alliance militarily defeated the English with plans to expel and ban them from returning to the continent. After exhausting all military means at his disposal, the English Army Captain Jeffrey Amherst implemented one of the most notorious exterminations in world history. During the cold and difficult winter of 1766, Amherst ordered blankets infested with smallpox for delivery to Pontiac's Alliance. A Jewish trader named [Levy Andrew Levy](#) successfully secured the smallpox-infested blankets and had them delivered to Pontiac's forces under the guise of being a gesture of goodwill. After accepting the blankets, Pontiac's forces were decimated. This extermination through chemical/biological germ warfare was swift, brutal, and devastating.

America's First Global Health Strategy was designed to exterminate the Native Americans in order to claim North America for itself. Ten years after this extirpation, the American Revolution was fought and America was born. This makes America a child born out of bioweapon warfare against the Native American population using medical "health assistance" as the vehicle.

Point 2: The Flexner Report – Instrument for Maintaining Medical Apartheid in America

In 1910, the infamous [Flexner Report](#) was released by its Jewish author, Abraham Flexner. It was an instrument used to standardize the American approach towards medical treatment, destabilize the practice of personalized medical diagnoses and care, and destroy the disciplines of homeopathic/naturopathic medicine to replace them with oil-based pharmaceutical products.

John D. Rockefeller via the Rockefeller Foundation funded the implementation of the Flexner Report's recommendations leading to the closure of medical schools nationwide. Black colleges and universities were hit very hard. Five out of the seven Black medical schools were defunded and closed. Only Howard University College of Medicine and Meharry Medical College survived this purge. Black hospitals were also shut down and the rate of licensed Black medical doctors being produced in this country stalled significantly.

Because of Black people's historical preference for natural healing practices/remedies and our traditional knowledge of herbs and their benefits, the results of the *Flexner Report* had far reaching impact on the Black community. After Flexner's recommendations were adopted throughout the country as enforceable medical policy, the established Black American healing practices were largely replaced by Western medical practices. Our historical approach to healing was systematically sabotaged, and in some cases even criminalized. A type of American Medical Apartheid was established.

Point 3. Margaret Sanger – Planned Parenthood, Another Term for “Genocide”

Margaret Sanger was an infamous American eugenicist in the early 1900's. Though not Jewish herself, she became a leader amongst a consortium of Jewish feminists and eugenicists like Emma Goldman, Fania Mindell, Rose Pastor Stokes, and many others. Sanger cofounded the first American birth control clinic in a Brownsville neighborhood located in Brooklyn, NY in 1916. She went on to found the *American Birth Control League (ABCL)* in 1921.

Eugenics is the science of controlling and regulating birth rates among targeted communities. Stated more directly, eugenics is the science of genocide through the prevention of births. These women worked with Sanger in the interest of tailoring the American population according to their desired economic, ethnic and racial designs. As it relates directly to Black people, Sanger wanted as few Black people to be born in America as possible. Hence, her birth control clinics naturally graduated into easily accessible abortion centers disproportionately located in predominantly Black communities.

Sanger created the “Negro Project” in 1939 for the express purpose of introducing Black people in the South to birth control. Under the auspices of “reproductive health” she galvanized Black political leaders, academics, and religious figures to promote her Black genocide efforts.

By 1942, the ABCL transitioned into the nonprofit organization known today as *Planned Parenthood Federation of America, Inc.* or simply *Planned Parenthood*. Since its inception, *Planned Parenthood* has been directly responsible for killing millions of Black babies. Margaret Sanger and her collaborators developed the infrastructure for the greatest known eugenics genocide in modern world history – the slaughter, through abortion, of Black babies in America.

Point 4: Tuskegee Genocide

By the late 1920's, with most Black medical schools in America closed and few Black medical professionals being produced, Black America was ripe for genocidal experimentation. In 1929, the *Julius Rosenwald Fund* (aka: Julius Rosenwald Foundation), funded a program to identify Black people in southern U.S. states infected with syphilis. Rosenwald was a Jewish businessman and philanthropist of means. By 1932 the U.S. Federal Government took control of this program.

The U.S. Government proceeded to invite Black men to Tuskegee University to test for syphilis, document the ones who tested positive, and monitor their deteriorating health while falsely pretending to treat them. Many of these men went blind, infected women in their lives, and even died without treatment. When penicillin was invented and known to be an effective treatment for syphilis, the government intentionally denied the men access. This genocide experiment continued until the program was stopped in 1972.

Under the guise of "health assistance," Black men were intentionally served a plate of genocide.

Point 5: NSSM 200

On December 10, 1974, under the direction of the Jewish American diplomat Henry Kissinger, United States National Security Advisor at the time, the [*National Security Study Memorandum 200: Implications of Worldwide Population Growth for U.S. Security and Overseas Interests \(NSSM200\)*](#), also known as the "Kissinger Report," was completed. This became the key document outlining the plan for global depopulation of nonwhite nations around the world.

With Margaret Sanger's eugenics efforts stifling the reproductive rate of Black Americans, Kissinger wrote the roadmap for attacking Black people in Afrika. Under the guise of overpopulation in countries like Nigeria, Kissinger argued that the best way to protect American interests was to concentrate on depopulation. NSSM200 made it clear that reducing the world's population of nonwhite people was its purpose. Under the Executive Summary, World Demographic Trends (30)(d), Kissinger writes:

(d) Creating conditions conducive to fertility decline. For its own merits and consistent with the recommendations of the World Population Plan of Action, priority should be given in the general aid program to selective development policies in sectors offering the greatest promise of increased motivation for smaller family size. In many cases pilot programs and experimental research will be needed as guidance for later efforts on a larger scale.

Paragraph (30)(c) of the same section reads:

(c) Increased assistance for family planning services, information and technology. This is a vital aspect of any world population program.

1) **Family planning** information and materials based on present technology should be made fully available as rapidly as possible to the 85% of the populations in key LDCs not now reached, essentially rural poor who have the highest fertility.

2) **Fundamental and developmental research should be expanded, aimed at simple, low-cost, effective, safe, long-lasting and acceptable methods of fertility control. Support by all federal agencies for biomedical research in this field should be increased by \$60 million annually.**

References to "family planning" mimic Margaret Sanger and Planned Parenthood's coded language for genocide. Kissinger took Sanger's American Black genocide program, extended the targets to all nonwhites, and made it **U.S. Government International policy**. At this point, both Afrikans in America and Afrikans in Afrika were presented as threats to America's national security and long-term interests. Afrikans' collective "depopulation" (genocide) was America's solution.

It should also be stated that the desire for greater access to resources in regions with low levels of economic development and high levels of natural resources was central in NSSM200.

To be clear, NSSM200 was broader than a genocidal assault on Afrikan people internationally. It targeted all nonwhite racial groups with increasing populations. However, Black people were a definitive target and worth isolating for the purposes of this discussion.

Point 6: Experimental Polio Vaccine, AIDS and the Assault on Afrika

In 1957 and 1958, Dr. Hilary Koprowski, a Jewish virologist and immunologist, tested his experimental oral polio vaccine on an estimated one million Black people between the Democratic Republic of the Congo, Burundi, and Rwanda.

By the early 1980's, *Acquired Immune Deficiency Syndrome (AIDS)* became a major concern in America. Even though the people dying in the U.S. were mostly gay White men, the origin of the disease was placed in Afrika. In fact, the commonly spread rumor was that AIDS was created by a man having bestial relations with a green monkey in Afrika.

By the 1990's, massive deaths of Black people occurred in the same locations where Dr. Hilary Koprowski administered his experimental polio vaccines. Many people believe these deaths were a delayed reaction to and the direct result of Koprowski's vaccine injections. However, the official narrative was that these deaths were a result of the AIDS epidemic. As a result, a disease that was initially reported as originating in the White gay communities of America, became the explanation for a major unexplained tragedy of Afrikan death in a very distant land.

Americans would later learn that Dr. Anthony Fauci was in charge of responding to the AIDS crisis in the 1980's and 1990's. We now know that people weren't actually dying from the sickness itself; rather, the AZT drug administered to AIDS patients by the hospital staff was actually killing most of them. In other words, we never actually had an AIDS death crisis. We had a premeditated medical murder of American citizens death crisis.

2006 Obama & Bioweapon Lab Negotiations in Ukraine

2014 Kenya Tetanus "Vaccine" Injections Laced with Anti-Fertility Agents

In 2014, the *World Health Organization (WHO)* and *United Nations International Children's Emergency Fund (UNICEF)* were caught administering a tetanus "vaccination" laced with an anti-fertility hormone called Human Chorionic Gonadotropin (*HCG*) to women and girls in Kenya. Some sources claim that over two million Kenyan women and girls were injected in this nationwide campaign.

Kenyan activists became suspicious when this effort required five different injections and was only targeted at women and girls of childbearing age. Concerned Kenyan citizens sent samples to South African labs to be tested. All samples submitted had the HCG anti-fertility hormone.

As a result of this bioweapon genocide waged against the Kenyan people, an estimated 500,000 women and girls were intentionally sterilized.

2014 Obama's Speech on Bilateral Support for Pandemic Preparation

On December 2, 2014, President Barack Obama gave a speech that hindsight suggests was aimed at soliciting U.S. political and economic backing to support the 2020 COVID-19 global pandemic response. He argued that the U.S. needed to create the international medical infrastructure to deliver "life-saving" vaccines and/or treatment to people in all regions of the world, especially the poorest places, in the event of an unexpected medical crisis.

Draped under the pretext of fighting the West Afrikan Ebola epidemic and preparing for "unpredictable" future pandemics, he accurately predicted the 2020 COVID-19 outbreak. During the speech he said:

"This is something I want to focus on for a second. Tony and I were fondly reminiscing about SARS and H1N1. *(pause)* That's what these guys do for fun. And we were lucky with H1N1 that it did not prove to be more deadly. We can't say we're lucky with Ebola because obviously it's having a devastating effect in West Afrika; but it is not airborne in its transmission. There may and likely will come a time in which we have both an airborne disease that is deadly.

And in order for us to deal with that effectively, we have to put in place an infrastructure, not just here at home but globally, that allows us to see it quickly, isolate it quickly, and respond to it quickly.

And it also requires us to continue the same path of basic research that is being done here at NIH that Nancy is a great example of so that **if and when a new strain of flu** like the Spanish Flu crops up, **five years from now** or a decade from now, we've made the investment and we're further along to be able to catch it. It is a smart investment for us to make.

It's not just insurance. It is knowing that down the road we're going to continue to have problems like this, particularly in a globalized world."

In December 2019, precisely five years after this speech, COVID-19 was announced to the American public. By January 2020, President Donald J. Trump publicly announced that America was facing a pandemic. He shut down entry to people coming from China and proceeded to lock down the entire country over the course of the next twelve months.

The historical evidence strongly indicates that Barack Obama cosponsored the creation of bioweapons labs in Ukraine in 2005, had advanced knowledge of the 2019 COVID pandemic at least as early as 2014, and tried to develop the infrastructure to have an internationally consistent medical response to treat victims when the pandemic occurred.

COVID-19: Modern Prototype for Bioweapon Warfare:

The worst bioweapon war against the people of planet Earth in world history occurred in 2020. It is commonly referred to as the COVID-19 pandemic. This section will highlight specific incidents that occurred relevant to the thesis of this paper to show how Black people worldwide were and are active targets of mass genocide under the guise of American medical assistance.

1. COVID-19 Fauci Hospital Death Protocol

The brutal reality is that very few people died as a direct result of "COVID-19." Instead, most people were murdered in hospitals with a death protocol prescribed and overseen by Dr. Anthony Fauci. Simply stated, American citizens were drowned to death in hospitals nationwide as part of a money-for-murder genocide scheme. A short summary of events went like this:

- a. In 2019, Ebola drug treatment trials occurred in Afrika. A drug called "Remdesivir" killed over half of the patients. It was deemed too dangerous to prescribe for treatment and removed from the trials.
- b. In 2020, when the COVID-19 pandemic was declared in the U.S., "Remdesivir" was prescribed as "THE ONLY OFFICIALLY APPROVED TREATMENT" for COVID-19 in hospitals across America.
- c. A money-for-murder medical scheme ensued whereby hospitals were incentivized to murder patients and classify their deaths as being the result of COVID-19 infections. There were a series of steps that allowed hospitals to make between \$100K - \$400K per patient killed, depending on the state of the hospital. Payments were generally made according to this order of events:

1st Payment – COVID-19 test of anyone who came into the hospital for any reason

2nd Payment – Any positive COVID-19 test result

3rd Payment – Anyone admitted to the hospital for COVID-19

4th Payment – Prescribing/administering "Remdesivir" for an allotted timeframe

5th Payment – Putting the patient on a ventilator for an allotted timeframe

6th Payment – Listing "COVID-19" as "Cause of Death"

The payments listed in bold above represent specifically critical phases of the murder operation. Not surprisingly, they made up a large percentage of the overall payments made to hospitals for this death protocol. Hospitals were incentivized to test as many people as possible, whether they were sick or not. They got paid equally for all tests. They made more money for every positive test reported. Hospitals were economically encouraged to admit as many people as possible as COVID-19 patients. Once admitted, a huge bonus was paid on the entire hospital visit to put the patients on "Remdesivir." After their kidneys began to shut down, liquids backed up into their lungs. They developed severe difficulty breathing. Hospitals were then heavily financially rewarded to put patients on ventilators to drown them to death. Lastly, in order to justify the notion that COVID-19 was the lethal mass killer of people, hospitals were paid to label COVID-19 as the cause regardless of what actually caused patients' deaths.

One of the primary incidents leading to this first *SA26 21st Century Afrikan Survival Position Paper* was a call from a Ugandan woman. She heard an interview I did on *Jake Shields Fight Back Podcast* in November 2025 and called me in tears. She personally experienced the exact same money-for-murder death protocol with her mother being the unfortunate victim. What struck me was that it happened in Uganda.

She explained to me that many people died from COVID-19 in Uganda. However, what was peculiar from her observation was that death only visited those who were in a financial position to afford hospital care. According to her, every single COVID-19 death she had knowledge of in Uganda occurred in hospitals.

When I heard her story, I instantly thought about Obama's 2014 attempt to advocate for more medical infrastructure in poor countries to address upcoming pandemics. Perhaps Obama's global medical support initiative was a designed genocide for the Afrikan continent.

2. Minor Consent for Vaccinations Act Amendment of 2020

In October 2020, Washington, DC, a predominantly Black city, proposed a bill that would allow 11-year-old children to consent to vaccinations without their parents' knowledge or consent. Concerned citizens in the Washington, DC metropolitan area organized to prevent this from passing. Conclusion:
